TENDER INQUIRY FOR PURCHASE OF MEDICAL EQUIPMENT

1. **Introduction:** Barnes School and Junior College, Devlali, invites sealed tenders from reputed and eligible suppliers for the supply and installation of medical equipment as per the list attached. The terms and conditions for submission of the tender are as follows:
2. **Scope of Supply:** The supplier shall provide the medical equipment as specified in the attached list. The equipment should comply with the technical specifications and standards prescribed.
3. **Eligibility Criteria:**
 - (a) The bidder must be a registered company/firm under relevant Indian laws.
 - (b) The bidder should have a minimum of 05 years of experience in supplying medical equipment.
 - (c) The bidder must provide valid GST registration and PAN details.
 - (d) Past performance certificates and customer references are required.
4. **Submission of Tenders:**
 - (a) Tenders must be submitted in a sealed envelope, clearly marked with "Tender for Medical Equipment – Tender No. BS/MEDICAL EQUIPMENT/20245-2025/14.
 - (b) The last date for submission is 31 Oct 2024 by 1200 hrs. Late submissions will not be entertained.

5. **Earnest Money Deposit (EMD):**
 - (a) An EMD of INR 2,000/- must be submitted along with the tender in the form of a Demand Draft, banker's cheque, fixed deposit from a nationalized bank, in favor of " B.E.S Barnes School" Account Number – 30161930121, IFSC CODE- SBIN0000360 payable at Devlali, Nashik. For vendors who are submitting their tenders via email, EMD can be paid directly into the account mentioned above and transaction details be mentioned in the tender document.
 - (b) The EMD will be returned to unsuccessful bidders within 05 working days. Tenders received without EMD will be rejected.
6. **Price:**
 - (a) Prices should be quoted in INR, inclusive of all taxes, duties and transportation charges.
 - (b) The prices quoted should be valid for at least 90 days from the last date of submission of the tender.

7. **Terms of Payment:**
- (a) 50% of the total cost will be paid upon placing of order.
- (b) 50% will be paid after receipt of the equipment at the school premises and inspection being carried out.
8. **Delivery Schedule:** The equipment must be delivered within Fifteen days from the date of purchase order issuance. Any delay in delivery will attract a penalty of 0.5% per day of delay subject to a maximum of 10 % of order value.
9. **Warranty and Support:**
- (a) The equipment must be covered by a comprehensive warranty wherever applicable which will be specified by the vendor for each item.
- (b) In case of any item failing in the inspection, vendor will provide replacement within 03 working days of intimation of the same.
10. **Inspection and Acceptance:** The supplied equipment will be inspected by the school's technical committee. Acceptance will be granted only after the equipment is found to meet the specified standards and specifications. Responding to this tender explicitly implies acceptance of terms and conditions laid down in this document.
11. **Part Tender Acceptable:** Vendor is to explicitly state if part tender is acceptable or not in the tender document.
12. **Dispute Resolution:** In case of any dispute, the matter shall be referred to arbitration under the Indian Arbitration and Conciliation Act, 1996. The venue of arbitration will be at [Insert City]. The decision of the arbitrator shall be final and binding on both parties.
13. **Jurisdiction:** The contract shall be governed by and interpreted in accordance with the laws of India. The courts in Nashik shall have exclusive jurisdiction over any disputes arising out of this contract.
14. **Termination:** Barnes School and Junior College reserves the right to terminate the contract at any time if the supplier fails to meet the terms and conditions of the contract.
15. **Right to Reject:** The school reserves the right to reject any or all tenders without assigning any reason thereof.
